NOTICE OF AMENDED CURE SCHEDULE

PLEASE BE ADVISED that on August 30, 2019, The News-Gazette, Inc. (“News-Gazette”) and D.W.S., Inc. (collectively with News-Gazette, the “Debtors” or “Sellers”) filed for relief before the United States Bankruptcy Court for the District of Delaware (the “Court”). The Court presides over the Sellers’ jointly administered chapter 11 bankruptcy cases (the “Chapter 11 Cases”) captioned *In re The News-Gazette, Inc., et al.*, Ch. 11 Case No. 19-11901 (KBO) (Bankr. D. Del. Aug. 30, 2019).

PLEASE BE ADVISED that on August 30, 2019 the Sellers filed with the Court the *Motion for (I) an Order (A) Establishing Bidding Procedures for the Sale of All, or Substantially All, of the Debtors’ Assets; (B) Approving Bid Protections; (C) Establishing Procedures Relating to the Assumption and Assignment of Executory Contracts and Unexpired Leases; (D) Approving Form and Manner of the Sale, Cure and Other Notices; and (E) Scheduling an Auction and a Hearing to Consider the Approval of the Sale; (II) an Order (A) Approving the Sale of the Debtors’ Assets Free and Clear of Claims, Liens, Interests and Encumbrances; and (B) Approving the Assumption and Assignment of Executory Contracts and Unexpired Leases; and (III) Certain Related Relief* (the “Sale Motion”).² By the Sale Motion, the Sellers seek, *inter alia*, to sell (the “Sale”) all or substantially all of their assets (the “Assets”) and to assume and assign certain executory contracts and unexpired leases (the “Designated Contracts”) to the Stalking Horse Bidder for such Assets (the “Purchaser”).

PLEASE BE ADVISED that on September 4, 2019 and September 18, 2019, pursuant to the Sale Motion, the Sellers served on all contract counterparties an individualized form of the Notice of Potential Assumption and Assignment of Certain Executory Contracts and Unexpired Leases and Proposed Cure Amounts [Docket Nos. 47 and 70, respectively] (the “Cure Schedule”).

PLEASE BE ADVISED that the Sellers received and resolved a number of objections and/or informal inquiries related to the Cure Schedule (collectively, the “Cure Objections”).

PLEASE BE ADVISED that the cure schedule attached as Exhibit A (the “Amended Cure Schedule”) reflects the Sellers’ resolution of the Cure Objections and/or other related changes.³ Attached as Exhibit B is a redline showing changes made to the Cure Schedule filed on September 4, 2019 and September 18, 2019.

PLEASE BE ADVISED that a hearing to approve the Sale of certain Assets (the “Sale Hearing”), including the assumption and assignment of certain Designated Contracts, will be held on **October 2, 2019 at 10:00 a.m. (prevailing Eastern Time)**, before the Court.
