  Plan of Liquidation; (C) Scheduling a Hearing on Confirmation of Debtors' Plan of Liquidation;
  and (D) Approving Notice Procedures, dated August 4, 2020 (Docket No. 399) (the "Solicitation Order"), Stretto was appointed and authorized to assist the Debtors with, inter alia, soliciting,

receiving, reviewing, determining the validity of, and tabulating Ballots cast on the Plan by holders of Claims in the Voting Classes (as defined below).

- 4. The Plan designated Claims in Class 2 (General Unsecured Claims) and Class 3 (Pension Claims) (the "<u>Voting Classes</u>") as Impaired and entitled the Holders of such Claims to vote on the Plan.
- 5. The Solicitation Order established August 6, 2020 as the record date for determining the Holders of Claims in the Voting Class who would be entitled to vote on the Plan (the "Voting Record Date").
- 6. On August 10, 2020, pursuant to and in accordance with the Solicitation Order, Stretto served the Solicitation Packages on holders of Claims entitled to vote on the Plan. An affidavit evidencing Stretto's service of the foregoing was filed with the Court on August 11, 2020 (Docket No. 407). Solicitation Packages were also forwarded pursuant to USPS forwarding instructions on August 31, 2020 as evidenced by Docket No. 435.
- 7. Copies of the Plan, and all exhibits were made available via the internet, free of charge at http://case.stretto.com/news-gazette on June 25, 2020.
- 8. Ballots returned by mail, hand delivery, or overnight courier were received by personnel of Stretto at the office of Stretto in Denver, Colorado. All Ballots received by Stretto were date-stamped upon receipt and were processed in accordance with the procedures set forth in the Solicitation Order.
- 9. For a Ballot to be counted as valid, the Ballot must have been properly completed accordance with the procedures set forth in the Solicitation Order and executed by the relevant Holder, or such Holder's authorized representative, and must have been received by Stretto by no later than 5:00 p.m. (prevailing Mountain Time) on September 16, 2020 (the "Voting Deadline").
