## **Order Granting Final Decree and Closing Chapter 11 Case**

4. The Creditor Trustee shall remit any distribution on account of the Gorgees' Claim to the Clerk of Court for further adjudication concerning disposition of the Gorgees' Claim.

5. The Internal Revenue Service is barred from asserting any claim on account of the Proposed Employee Shared Responsibility Payment in this Case.

6. The Creditor Trustee is authorized to pay the PR Tax Claim. Puerto Rico is barred from asserting any additional fees, penalties, expenses or other claims in this Case.

7. The Wind-Down Reserve is approved.

8. The bankruptcy case of Perfect Brow Art, Inc. administered under case number 19-01811, is
